The information provided in this newsletter is a summary of academic performance for students who took New York State Assessments in the 2016-2017 school year.

New York State Report Cards provide comprehensive data for all districts in the state, including enrollment, demographic, attendance, assessment, accountability, graduation rate and much more. The comprehensive state reports are available online from the New York State Education Department Report Card website at https://reportcards.nysed.gov.

State assessments are designed to help ensure that all students reach high learning standards. As required by the State, students that are not making appropriate progress toward the standards, must receive academic support.

Report Card review dates have been scheduled at each school. Parents and guardians are encouraged to participate in these very important discussions. School Report Card meetings will take place at each building on the dates and times listed in the box below.

UPDATE ON NEW YORK STATE FINAL COST REPORT PENALTY

The North Syracuse Central School District has created a website for sharing information about the penalty imposed by New York State for the late filing of final cost reports for certain capital projects. All updates and documents related to the penalty and possible relief are posted at www.nscsd.org/penaltyupdate.

The district is in direct contact with the governor's office and is working with our New York State senators and assembly members to advance legislation that would provide the district with relief from these penalties.

Local legislators have been very supportive and the district is appreciative of their efforts. We believe that they will continue to do as much as they can to seek penalty relief and we encourage our community members to contact the governor's office, assembly, senate and legislators to advocate on behalf of the district.

School Accountability Status

Participation Standard refers to how many students took the State exams. The New York State Education Department requires that at least 95% of students participate in State testing.

Performance Index refers to the student's performance. The New York State Education Department uses a formula to calculate this number which includes how many students score at each level (1,2,3 or 4).

AMO or Annual Measurable Objective is a number set by the New York State Education Department that is a target for student performance.

Adequate Yearly Progress refers to whether or not a group has performed above the AMO. A school that meets or exceeds AMO is said to be in good standing.
