# Capital Project Proposition



### **District-Wide Security Enhancements: \$32,000,000**

- Address safety and security items throughout the District.
   Standardize systems District-wide.
- Update bathroom facilities at North Syracuse Junior High School for ADA accessibility.

# Gillette Road Middle School & North Syracuse Early Education Program: \$21,200,000

- Replace end of life heating/ventilation at Gillette Road
   Middle School and add air conditioning.
- Replace water main and complete major roof re-coating at North Syracuse Early Education Program.

### **Gillette Road Athletic Complex: \$8,000,000**

- Install an artificial turf baseball field with multipurpose outfield and resurface walking trails at Gillette Road Middle School.
- Reconstruct parking areas at Gillette Road Middle School.

### **Total Proposition Amount: \$61,200,000**

Estimated Tax Levy Increase Less than 1/2 percent (0.41%) \$9 annual increase before STAR on home valued at \$100,000

### Tax Impact

**Total Project Cost** 

\$61,200,000

Building aid will cover most of the project cost with debt service reductions offsetting a significant amount of the local share, thereby minimizing the tax impact.

Estimated Tax Levy Increase Less than 1/2% (0.41%)

\$9 annual tax increase before STAR on home valued at \$100,000

### Where Do I Vote?

- Residents who live SOUTH of Rte. 481 Vote at the Administrative Office Bldg. (5355 West Taft Road in North Syracuse)
- Residents who live NORTH of Rte. 481 Vote at Cicero Elementary School (5979 Route 31 in Cicero)

### **Information for Voters**

**Voter Qualifications:** In order to vote in the Dec. 6, 2022 election, you must be a United States citizen, 18 years of age or older and meet the following qualifications:

- A resident of the school district for at least 30 days prior to the vote,
- Not under sentence for a felony conviction and not adjudged mentally incompetent,
- Registered to vote in Onondaga County or the North Syracuse Central School District.

**Registration Information:** If you are not registered to vote, you must pre-register by Nov. 29 to vote in the Dec. 6 election.

- Until Nov. 29 from 8 a.m. to 4 p.m., Monday through Friday at the Jerome F. Melvin Administrative Office Building, 5355
   West Taft Road in North Syracuse
- On Nov. 29 from 4 p.m. to 8 p.m. at Cicero Elementary School, 5979 Route 31 in Cicero and at the Jerome F.
   Melvin Administrative Office Building, 5355 West Taft Road in North Syracuse

### **Absentee Ballots**

Qualified voters of the District may obtain applications for an absentee ballot from the Office of the District Clerk. Completed applications must be received by the District Clerk no later than 5 p.m. on Dec. 5, 2022 and must be received no later than 5 p.m. on Nov. 29, 2022 if the absentee ballot is to be mailed to the voter. Completed applications received after 5 p.m. on Nov. 29, 2022 will require the voter to personally appear at the Office of the District Clerk to receive an absentee ballot. A listing of all persons to whom an absentee ballot is issued will be available for inspection by any qualified voter in the Office of the District Clerk between the hours of 9 a.m. and 4 p.m. through Dec. 5, 2022, other than on a Saturday, Sunday or holiday.
