
### A Message from Pat V. Carbone, President of the Board of Education

The Board of Education is responsible for developing a school budget that provides all of our students with the resources to meet the rigorous state standards. We are also responsible for keeping the tax rates as low as possible for the residents of our community. Balancing these priorities continues to challenge us and this year is no exception. This year is especially difficult because of the depressed economic environment.

For the third year in a row, the District has seen a reduction in State Aid. As a result, the Board of Education has reduced approximately 67 positions in the proposed budget. Over the past two years, the Board of Education has reduced an additional 135 positions.

The Board of Education has also negotiated contracts with most of the unions spreading pay increases over a two-year period and gained health insurance concessions of approximately \$1,200,000. However, we have maintained a quality educational program for our students in our efforts to be fiscally responsible to the taxpayers.

We are proposing a \$136,601,471 budget on the May 17<sup>th</sup> ballot. The proposed budget is \$1,807,618 less than the 2009-2010 budget.

The proposed budget results in an estimated tax increase of 5.2 percent in Cicero, in Clay, and in Salina.

# The 2011-2012 School Budget



Dear Residents,

The proposed 2011-2012 North Syracuse Central School District budget would result in an estimated 5.2 percent tax rate increase if approved by school district residents on May 17, 2011. The budget itself is up  $\frac{8}{10}$ th of one percent, or \$1,134,411 more than 2010-2011. The preliminary budget is \$1,807,618 less than the 2009-2010 school budget of \$138,409,089.

A reduction of \$8.9 million in state aid and a preliminary budget increase of \$6,424,122 contributed to an initial shortfall of \$15,324,122 in February. For the third consecutive year, the North Syracuse Central School District experienced the very worst of a weak state and national economy as indicated by a major reduction in state aid. Although \$1.7 million of the original \$8.9 state aid cut was restored, the School District still lost \$7.2 million in state aid for 2011-2012, bringing the total three year loss in Foundation Aid to \$19.7 million.

Aware of the financial constraints facing community residents, the preliminary budget was reduced by approximately \$5,289,711 through significant program and staff reductions and economies. Consequently, it has been necessary to eliminate 67.15 positions throughout the School District. This brings the reduction to approximately 200 positions, including administrative, instructional, and support personnel, that have been eliminated during the past three years. Regretfully, forty-five staff members will be laid-off, effective July 1<sup>st</sup>.

At the Board's insistence, for the most part, the integrity of the academic program has been maintained, though class size has increased, especially at the secondary level. Major reductions in non-instructional areas could not offset the need for instructional program reductions and the loss of teaching positions.

Contributing to the less than one percent budget increase are the following:

- Employee Benefits - \$1,080,404 increase due to a 6.5% increase in health

insurance rates, 28% increase in Teacher Retirement System rates, 39% increase in Employee Retirement System rates, and need to fund benefits for those positions formerly paid for by the Federal Stimulus grants (Stabilization Funds) which expire June 30, 2011;

- BOCES Services - \$573,932 increase due to participation in Special Education Work-Study program and a higher number of seriously disabled students in BOCES programs;
- Debt Service (Principal and Interest) - \$174,422 increase due to Smith Road Elementary School renovation project – totally offset by New York State building aid and debt service reserve funds;
- Fuel for Vehicles - \$150,735 increase due to higher costs for bus fuel;
- Tuition costs to New York State Institutions and Charter Schools - \$105,000 increase due to additional North Syracuse residents attending charter schools.

There are four significant areas of the budget that decreased. They are:

- Salaries - \$456,076 decrease due to the elimination of 67.15 positions and staff salary concessions;
- Utilities - \$200,000 decrease due to coordinated energy reduction program that has proven effective at all levels;
- General Supplies - \$186,363 decrease due to reduction in supplies district-wide;
- Other Contracts - \$71,070 decrease for payments to public schools for health services for North Syracuse Central School District residents attending private schools in those communities.

A year ago in this Budget Message, I wrote that the School District would lose \$2.9 million in Federal Stimulus grants, effective June 30, 2011. Those funds were provided to school districts during the last two years to prevent major staff layoffs. The loss of those funds, along with continued reductions in state aid, has been the major cause of staff layoffs and a higher tax rate increase. Also, I would be remiss if I did not point out that the School District will lose approximately \$3.1 million

in Federal Jobs Fund money which expires June 30, 2012. Again, the threat of continued state aid reductions, as well as the loss of the Jobs Fund money, places added emphasis on budget planning and allocation of dwindling resources during the next budget cycle, 2012-2013.

As is the School Board's practice, in order to give residents a clear understanding of the school budget, a multi-page program budget will be available at the May 3<sup>rd</sup> Public Hearing. This document describes each program, along with costs, program objectives, and accomplishments. 



# Proposed Budget for 2011-2012

**Program Component** – The program component represents the largest portion and focal point of our budget. Items contained here represent the “heart” of any educational system. The component represents 76% of the total budget. Included are all instructional expenses including regular instruction, education of the disabled, occupational education, curriculum and staff development, and summer school. Also included are pupil services such as health, guidance, library, co-curricular, athletics and transportation. Associated fringe benefit expenses, legal and community service expenses are also included.

# School Board Candidate Biographies

The Board of Education is the official policy-making body of the North Syracuse Central School District. The board is composed of nine members who are elected by district voters to three-year terms. Members receive no salary for serving on the Board. The terms of three board members expire each year on June 30<sup>th</sup>. Board members may seek re-election at the annual budget vote. New York State law does not limit the number of terms a board member may serve. To run for board membership, you must be a resident of the District for more than one year and have your name placed on the ballot by having a petition signed by eligible voters and filed with the District Clerk within a specified time. This year, there are four candidates running for three vacant seats due to expiration of the terms. The three candidates receiving the highest number of votes will be elected to three-year terms (from July 1, 2011 to June 30, 2014).

## **Pat V. Carbone**



Pat V. Carbone resides with his wife and two children at 405 Leroy Road in Cicero, and is a 1976 graduate of Henninger High School in Syracuse. Pat has a daughter who graduated from the College of St. Rose, and is currently attending NYU to complete a post graduate certification. Pat also has a daughter attending Canisius College in Buffalo. Both daughters attended Cicero-North Syracuse High School. Carbone received a Bachelors Degree in Political Science with a minor concentration in Accounting from LeMoyne College, and is presently employed as a Territory Manager and Commercial Loan Officer for the Liverpool, North Syracuse, and Cicero branches of Solvay Bank.

He has been a member of the Board of Education for the past 18 years and has served on the Board of Education's Policy Committee, Legislative Committee, Audit Committee and Executive Committee, the Career Education Advisory Council and has served as President of the Board of Education since May 1996. He has served as an officer of the North Syracuse Chamber of Commerce, and was previously President of the North Syracuse Rotary Club. Carbone currently serves on the Board of the Onondaga Madison School Boards Association, is a member of New York State School Boards Association, and is the past Treasurer of North Syracuse Cemetery Association.

Carbone believes that the key to effecting fair change,

and having a true impact on the decision making process, is through direct involvement. In these financially challenging times we must combine all of our talents and ideas to collectively formulate policy that benefits the district, the district's employees, the community, and most importantly, the students.

## **George Harrington**



George Harrington resides in North Syracuse with his wife Denise. Harrington's three children, Sara, George and Laura also attended and graduated from the North Syracuse Central School District.

Harrington is employed by Precision Systems Manufacturing as a Technical Sales Engineer.

Harrington has been active in the various schools as a member of the Parent-Teacher Organizations and Booster Clubs and is currently a member of the North Syracuse Board of Education. Harrington also serves as a director at the North Syracuse Cemetery Association.

Harrington feels that with the children being our future, that by participating on the School Board, he can help achieve the visions of the district's students, teachers and community.

## **Scot McClintock**



Scot McClintock has lived in the North Syracuse Central School District for thirty-four years. He resides in the Town of Clay at 7740 Japine Drive with his wife Lori, a second grade teacher at Allen Road. Daughter Sara is a speech pathologist in Boston; daughter Holly is a registered nurse at Upstate; and daughter Lindsay is an Associate Account Services Specialist for Partners in Health Systems. All three daughters have benefited greatly from the district's fine academic programs and a girl's cross country and track program with the emphasis on each athlete enjoying success through hard work.

McClintock graduated from Newburgh Free Academy in 1970. He completed a BS in Civil Engineering in 1974 and a Masters of Engineering in 1975 from Cornell University. A licensed Professional Engineer and Certified Value Specialist, he is the head of Value Management for Faithful+Gould, applying the concepts of Value Management to provide essential functions of major projects or programs at the minimum life cycle cost.

McClintock serves as the Board representative on the Hancock Field Development Board. He has used his knowledge of the District's facility needs and Value Management techniques over his eighteen years on the board to help the Board of Education make necessary, but cost-effective, decisions.

McClintock's goal of being part of a successful referendum to renovate our school facilities has been met eight times. He has led seven Value Management workshops on the District's technology plan, and the renovation plans for Cicero-North Syracuse High School; Allen Road, Roxboro Road, and Smith Road Elementary Schools; and both Gillette Road and Roxboro Road Middle Schools resulting in savings of nearly \$8 million. He also recognizes the need to continually improve communication between

the Board of Education and the taxpayers so the community can understand and support Board recommendations and budgets.

As a taxpayer, McClintock is proud of the District, but concerned about improving our student's academic performance while state aid is continually threatened by the economy and New York State politics. He also believes that the District, meaning taxpayers, students, parents, administrators, teachers, and the Board of Education, must work together to solve these problems and many others. ## Voter Qualifications

Voters must be:

- 18 years of age
- A citizen of the United States
- A legal resident of the school district for at least 30 days prior to the vote
- Not under sentence for a felony conviction and not adjudged mentally incompetent
- Be registered with the Onondaga County Board of Elections, pursuant to Article 5 of the Election Law.

*NOTE: A post office box is not an address of residency. Voters must reside in the district, not just maintain a post office box.*

**Tax Exempt Parcels**

The number of exemptions in the town of Cicero is 8,013 equaling 22.7% .

**Salina Free Library Proposition**

Shall the annual appropriation for the Salina Free Library within the School District be increased from \$382,454 to \$393,000, such sum to be raised by levy of a tax upon the taxable property of the District located in the Town of Salina in accordance with Section 259 of the Education Law?

**Bus Bonding Proposition**

Shall the Board of Education of the North Syracuse Central School District (the “School District”) be authorized to purchase ten (10) 65-passenger diesel school buses at an estimated maximum cost of \$105,690 each; one (1) 39-passenger diesel school bus with one to three wheelchair positions and air conditioning at an estimated maximum cost of \$118,071; and one (1) 48-passenger bus with air conditioning at an estimated maximum cost of \$105,487 for a total estimated maximum cost of all such vehicles not to exceed \$1,280,458, and to obtain the necessary funds by the levy of a tax upon the taxable property of the School District to be collected in annual installments in the years and in the amounts as the Board of Education shall determine in accordance with Section 416 of the Education Law, and, in anticipation of said tax, to issue up to \$1,280,458 in obligations of the School District?
