Please note: This form needs to be completed in full and returned prior to the Chromebook being issued.

A North Syracuse Central School District ("NSCSD") Chromebook is being loaned to the Student identified above for academic purposes. It is imperative that parents/guardians stress to their children how important it is to take good care of their issued device and to behave appropriately when interacting with others digitally. Certain rules are necessary to protect the Chromebook and ensure that this technology serves as an effective instructional tool. By accepting possession of a NSCSD Chromebook, the Student and his/her parents/guardians agree to the following:

1. NSCSD does not permit unethical use of the internet, email or any other media. The Student agrees to follow all NSCSD policies and regulations governing the use of Chromebooks, including but not limited to NSCSD's Acceptable Use Policy and the NSCSD Student Code of Conduct. Violation of these policies may result in the loss of Chromebook loan privileges and/or disciplinary action by NSCSD.
2. The Chromebook is the property of NSCSD. If the Student withdraws from school prior to the end of the school year, the Chromebook must be returned to NSCSD prior to withdrawal.
3. The Student agrees to keep the Chromebook secure and safe. There is no charge to lend a Chromebook to a Student. However, by signing this agreement the Student and his/her parents/guardians agree to pay the full cost for any repair if the Chromebook is damaged in any way due to the Student's neglect or misuse. The Student and his/her guardians/parents also agree to pay the full cost to replace the Chromebook if it is lost, stolen, or not returned for any reason. The current replacement cost of the Chromebook is \$250, and is subject to change.
4. The Student agrees not to install or use any software other than software owned or approved by NSCSD and made available on the Chromebook. The Student agrees not to make any unauthorized use of or modifications to such software.
5. The Student agrees to bring the Chromebook to school each day, sufficiently charged to meet the Student's daily usage needs.
6. The Student must report theft (or suspected theft) of the Chromebook, loss of the Chromebook, damage to the Chromebook, or malfunctioning of the Chromebook to school personnel within 24 hours of any incident.
7. The Chromebook cannot be loaned, sold, traded, leased, rented or given to any other person without the express written consent of NSCSD.

For Students: I have read and agree to comply with these rules and all NSCSD policies and regulations for use of the Chromebook, including the NSCSD Acceptable Use Policy and NSCSD Student Code of Conduct. I acknowledge and agree to my responsibility to ensure that the Chromebook is used for school-related educational purposes only.

For Parents/Guardians: I recognize the need for, and will exercise appropriate parental control to ensure that my child does not use the Chromebook to access inappropriate content or for any other inappropriate purpose. I understand that NSCSD may require return of the Chromebook if it is used inappropriately, and I agree to release and hold harmless NSCSD from any liability as it pertains to inappropriate use of the Chromebook while on loan to my child. I have read and agree to comply with all terms and conditions stated above.
