SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. The ARP information was shared via formal presentation at a public Board of Education meeting and posted on the district's website. NSCSD has had several discussions with various stakeholder groups about the use of ARP funds. Specifically, we have shared detailed information with our Board of Education, leadership teams and various shared decision-making groups / processes including both labor and management. There have also been discussions with Teacher Union Leadership. Our focus has been to work with the areas and personnel most impacted such as early education, elementary education, and our Social & Emotional Learning Coordinator. The general public's opportunity for engagement was at a public meeting (BOE) where the plan was discussed and the floor opened for comments and questions. We will continue to engage stakeholders via regular meetings and updates on spending and progress against specific initiatives. ARP funding and its impact on the 2021-22 budget will be included in our upcoming budget presentations. We expect that this will result in additional meaningful conversations about the continuing impacts of COVID and the best use of relief funds with both staff and district residents.

We will continue to provide masks and hand sanitizer to all students and staff. As noted elsewhere in our application, we are focused on reduced class sizes which improves social distancing. The new furniture will allow for easier reconfiguration of class spaces so that social distancing can be maintained while enhancing the instructional environment. Further, we believe we can clean the newer furniture more effectively than the old furniture, which often has surfaces that are more difficult to sanitize.

4. **In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

Student progress will be measured by a September, January, and May administration of AIMSweb assessment. This is a nationally-normed standardized assessment. We will be monitoring overall academic achievement and student growth in both Math and English Language Arts for all students.

The 2.0 instructional coaches, 3.0 classroom teachers, and 3.0 instructional teaching assistants will be used to offer embedded instructional support targeted for students reading below grade level. They will be both directly providing student reading interventions and supporting teachers in developing their skills and competencies in delivering the following interventions: small group instruction, decoding, ear reading, paired reading, phonics instruction (k-2 setting), reading comprehension support, and fluency support and instruction.

Additionally, the 2.0 special education teachers will deliver specially-designed instruction, progress monitoring in ELA and Math, and implement the following interventions within the classroom setting: timely, classroom-embedded feedback, continuous progress monitoring using AIMSweb achievement data, and specially-designed instruction intended to address known learning deficits.

Addition of 2.0 Instructional Coaches, 3.0 Teaching Assistants, 2.0 Special Education Teachers & 3.0 Elementary Teachers to Elementary Schools (K-6) to support the implementation of high-leverage instructional practices, monitor student progress, reduce class size and offer small-group targeted interventions to address learning loss and students' social-emotional needs. All will work with all content area staff who support all students. (FS-10 Code 15 & Code 80).

The district has been without a Director of Technology for nearly a decade. This new position will help coordinate with other Directors and Principals on the district's technology needs. Five new teachers will be used to reduce class sizes. One language teacher will be hired due to an increase in our ELL needs.

On the support side, an additional Maintenance Worker II, Registered Nurse and Bus Attendant will all address increased needs in their respective areas.

The district will use ARP funds to cover additional TAs that were required at the North Syracuse Early Education Program, allowing the program to continue providing quality Pre-K education to both typical students and students with disabilities. The district will also put on 3 clinics based on Elementary Aged mental health and send personnel to conferences that cover restorative practices.

Below is a description of how the use of funds will address academic, social, emotional, and mental health needs of the students in four of the subgroups:

Low-income Families - We have added additional staff to provide support for these families. Specifically Counselors, Social Workers and teachers to reduce class sizes (to levels lower than other school with higher wealth). We have implemented a new restorative practices program to better support students and families.

ELL - Additional teachers have been and will continue to be hired to support this group as the number of students in need has increased.

Children of Color - Instructional Coaches will be training staff in the implementation of culturally relevant pedagogy in the classroom.

Children with Disabilities - Additional teachers have been and will continue to be hired to support this group as the number of students in need has increased.
